ORDER:

In the reference 1st read above, the Principal Chief Conservator Forests, Andhra Pradesh, has submitted a proposal for construction of “**State of Art Godown**” to accommodate 4000 to 8000 MTs of red sanders logs with an estimated cost of Rs.21.08 crores consisting of six numbers of godowns, a central auction hall, administrative block, service block, security block, weigh bridge, central monitoring system with CC cameras, solar lighting system, internal roads etc. The construction of these six numbers of godowns can be taken up in two phases, in which the first phase consisting of three numbers of godowns to accommodate 4500 MTs. of Red sanders logs can be commenced at a cost Rs.10.00 crores and the balance amount of Rs.11.00 crores can be released in the 2nd phase after completion of this initial construction work.

2. Government after careful examination of the proposal of the Principal Chief Conservator Forests, Andhra Pradesh, hereby agree in-principle for construction of Godown Complex at Tirupathi as detailed in para One (1) above, for storage of Red Sanders wood, with a direction to prepare realistic estimate as per the provisions of G.O.Ms.No.94, I & CAD (PW-COD) Department, dt.01-07-2003.

3. The expenditure shall be met from the Head of Account **4406- Capital outlay on Forestry & Wildlife - 01 - Forestry - 101 - Forest Conservation development & regeneration - GH-11 – Normal State Plan - SH (06) – Godown Complex construction for storage of Red Sanders wood - 530 / 531 – Other expenditure (to be opened)**

4. This order issues with the concurrence of Finance (EBS.VII, MA &F) Department vide their U.O. No. 3965/031/A2/EBS.VII, MA &F/2014, dated. 20-10-2014.

5. The Principal Chief Conservator of Forests, Andhra Pradesh, Hyderabad is requested to take further necessary action in the matter accordingly.
